You Haven't Made A Will Because —

You feel it isn't necessary since your wife will get everything without one. So why go to the trouble? Not true. If there are children, she may not get everything. By law, the children will be entitled to a share of your property. A guardian, most likely your wife, will be appointed by the court to handle it, but her expenditures will be under the supervision of the court, and the expenditures must be only for the children. If there are no children, she still may not get everything. Some of your relatives may get a share.

You don't like the idea of making a will because it's associated with death. Everyone prepares for the future in some way — by saving money, buying life insurance, and so on. Making a will is just another way of preparing for the future. It helps insure the continuity of what you have been doing right along — providing for your family.

You won't leave enough to make a will worthwhile or necessary. Do you own a house, a car, furniture? Do you have a bank account, life insurance? Then you may have more of an estate than you realize! No matter how much it amounts to, a will makes sure it goes to those to whom you want it to go, and you can name the Executor to settle the estate.

It's too expensive to draw up a will. Not so. For most people only a simple, uncomplicated document is necessary. Its cost will be moderate — probably much less than you think.

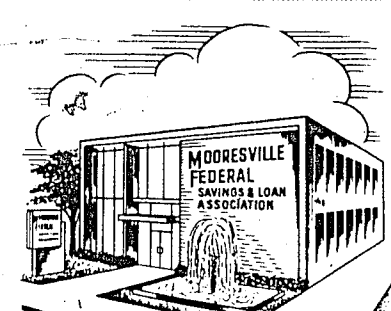
